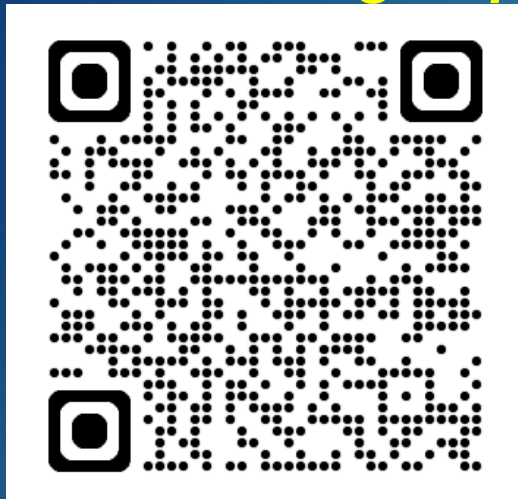

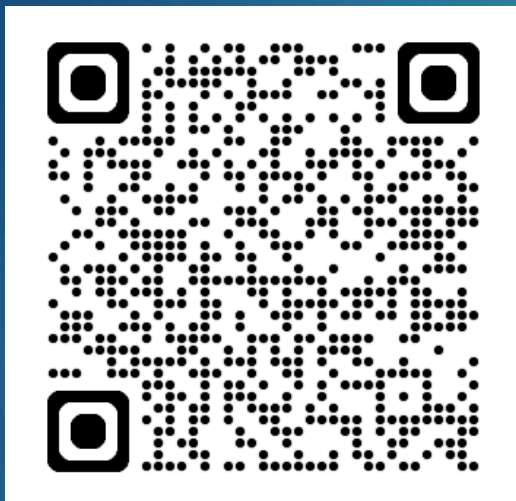

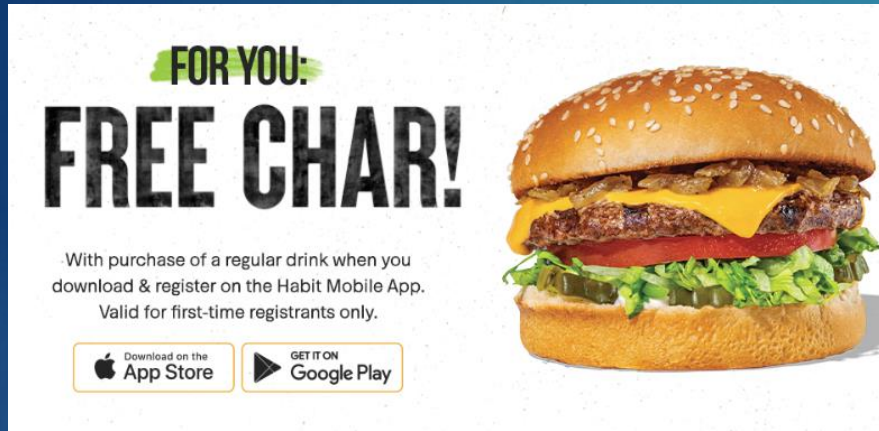

RAFFLE GUIDELINES

A few important points of note:

- * Only HTBC members can sell tickets.
- * No sales to minors.
- * We can accept cash or credit card payments, but no internet sales. We need physical sequentially numbered tickets. This means we cannot use Zeffy to administer the raffle online, but we can accept credit card payments through Zeffy or CashApp.

ACTION ITEMS

- * Need to decide on the price per ticket, somewhere between \$1 and \$10 each is recommended.
- * Need to purchase raffle tickets. We'll need to use raffle ticket double rolls that include name/address/phone. It looks like a roll of 1000 sequential tickets is less than \$10 on Amazon. <https://a.co/d/jfy7eBd>
- * Need HTBC members (2 or 3?) to sign up to sell tickets at the **11/6 and 11/7** events. Or option to include **11/8** for Dance/Choir event. Times 7PM.

- * Need to have QR codes ready for Zeffy and CashApp payments. I know they are linked on the HTBC membership form, but I would recommend putting direct links for raffle ticket purchases printed on the back of the raffle flyer or on a separate page to display at the raffle kiosk.

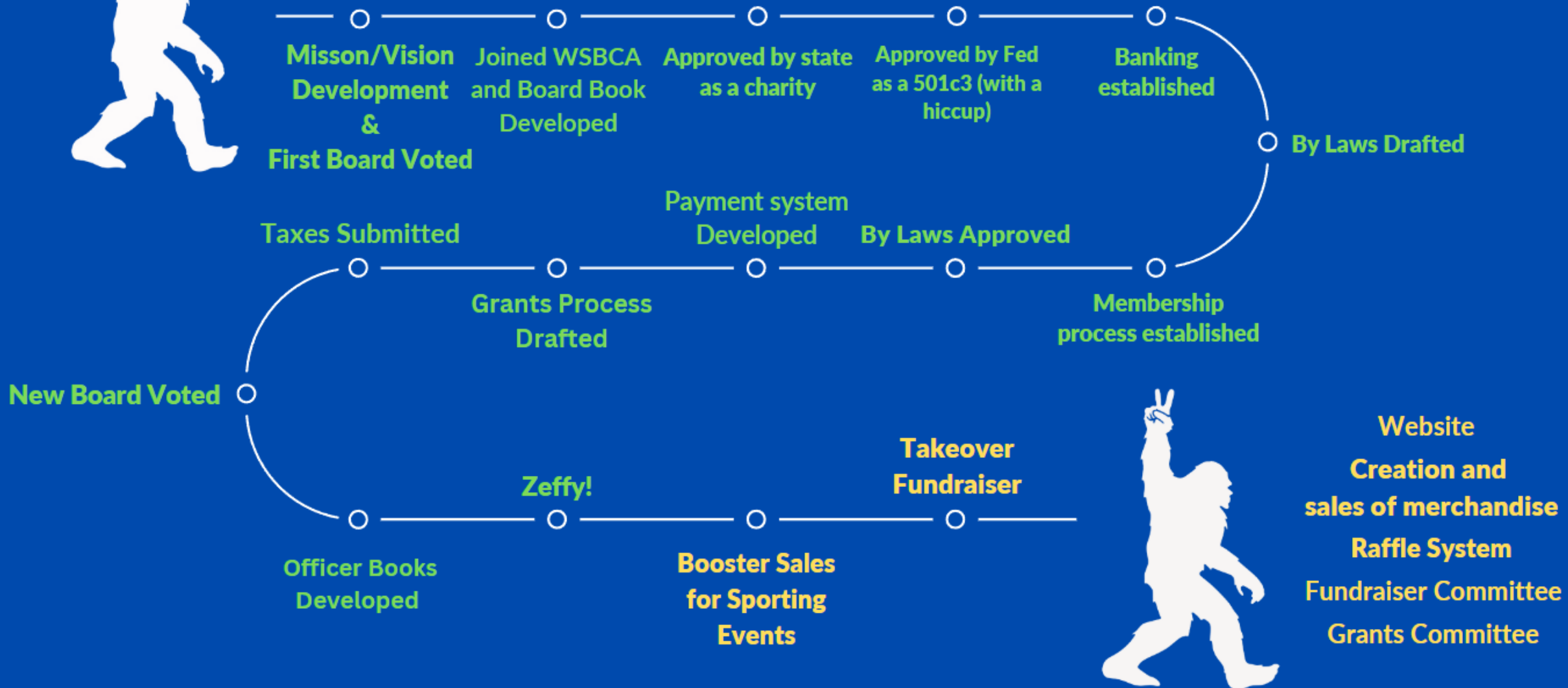
